1, Bible was fabricated to make up Jesus, "the son of Jehovah."

The main reason why the Gentiles envied, emotionally cursed, and persecuted the Jews was because of the Jews' racist nationalism.

In fact, there has been no country in ancient society or even in modern society that has not considered "racist nationalism" a virtue.

However, because of the false notion that Judaism is the root of conservative Christianity, both Jews and Gentiles have continued to engage in bizarre wars and conflicts.

When individuals or groups insist on wrong ideas, it becomes violence and only leads to disaster and mad destruction for themselves and many others.

The reasons why Jesus was transformed into the idea of "Son of Jehovah" are as follows :

11 Whenever the unclean spirits saw Jesus, they fell down before him and shouted, 'You are the Son of God !' 12 But he sternly ordered them not to make him known. (Gosepl of Mark chapter 3, verse 11-12)

2, The reason Jesus sternly ordered people not to call him the "Son of God" was that, at the time, the Roman emperor was also called the "**Son of God**," so he and his disciples could have been accused of rebellion.

3, Jesus never once called himself the "**Son of God**," but due to the ancient custom of calling great figures the Son of God, Jesus was executed for rebellion, and for his disciples and Christians who were hostile to the Romans, in the process of commemorating Jesus and theorizing about his miracles in the

Bible, Jesus was unintentionally exaggerated as the Son of God, "**the Son of Jehovah.**"

4, Jews scattered throughout the world were able to take pride in preserving their Jewish traditions and language, instilled in the fact that Christianity, which is worshipped by people all over the world, has its roots in their own Judaism. However, because of this, Jews had to pay a harsh price because of Judaism, the "superstition of Israel."

In order to protect the vicious racist nationalism of Judaism, they were ethnically cleansed by the devil Hitler, who was 1/4 Jewish, and they also suffered damage due to the absurd Judaism that made a devil equal to Hitler a leader like mad dog Netanyahu.

Mark chapter 7

25 a woman whose little daughter had an unclean spirit immediately heard about him, and she came and bowed down at his feet. 26 Now the woman was a Gentile, of Syrophenician origin. She begged him to cast the demon out of her daughter. 27 He said to her, 'Let the children be fed first, for it is not fair to take the children's food and throw it to the dogs.'

This passage sounds even a lot stranger and a lot more absurd than bald actor Yul Brynner wearing a white racist Trump's blonde wig in his movie "The Ten Commandments."

The passages in the Gospels that begin to repeatedly call God "Daddy, Father," even though Jesus never referred God as Father, may have been because :

1. The Gospel of Mark was based on the original "seed gospel of Paul," which was based on the "son of God theology" of Paul, who had never met Jesus in the flesh except through prayer communication.

The Gospel of Paul has never been mentioned in history and is only a conjecture, but it is possible that it was distributed to the bishops in the areas and circulated where Paul preached before being officially released to the general public in an exaggerated form like the "Gospel of Mark," and that "seed Gospel of Paul" may have become the raw material for the skeleton of the first Gospel of Mark.

2, Israel, where a small population had to desperately survive in the cracks between super powerful countries to survive, extremely detested associating with

foreigners for the sake of national survival and considered it a crime punishable by execution, referring to foreigners as humiliating "Dogs."

This is not something to be criticized or condemned as a national sentiment that existed not only in Israel but also in all ancient countries, even modern countries, as a strong will to survive to protect the country by emphasizing extreme and exclusive nationalistic racism in ancient society.

3, The Apostle Paul was the one who solved the problem of "Why should we preach to the Gentiles?" which was a remaining grave task for the disciples of Jesus, who were not able to escape the Jewish racism and nationalism of Israel by themselves.

Although Peter was the head of Jesus' disciples, the social standing and academic weight that the Apostle Paul, an orthodox Pharisee of Pharisees, possessed were so great that Peter, who was just a poor fisherman, would have difficulty following it.

4, Rather than saying that Jesus actually called the Gentile woman a DOG, this passage should be seen as an attempt to justify the answer to the question, "Why should we preach Christianity to the Gentiles who are dogs?" by borrowing the authority from Jesus' mouth.

Then, who technically justified "the mission to the Gentiles" by borrowing the authority of Jesus was apostle Paul or Mark, the author of the "Gospel of Mark?"

This passage may have been invented by Mark, the author of the Gospel of Mark, or it may have been **the answer and conclusion** reached during a discussion among the Jewish Christian disciples regarding the question, "Why should we preach Christianity to the Gentiles?"

Can you free yourselves from the nightmare-like, humiliating curse of mockery from "Dog Gentiles" that has pissed over the faces of billions of humankind for

two full millennia ?

If you are happy and free from this biblical humiliation now, I believe your Christian faith could be something more joyful & confident than popes and cardinals, don't you?



3. Manipulating pretexts for missionary work to Gentiles.

The reason why more than half of the ordinary modern people reject Christianity is that it is a selfish Jewish, ethnically discriminatory religion, and the next reason is that Christianity imposes rules that are difficult and confusing to put into practice, like many solemn and odd ethics teachers.

As a theologian and believer who met and listened real Christ in person for one full hour 3 decades ago, if we remove the exaggerations and errors written in the Bible, Christianity is a practical religion that can be fully understood by reason and conscience, and Jesus is also a kind and accurate administrator for humans, not a god for gods.

Religion has the sweet temptation of eternal life, but it also has so many traps that unless you meet a good priest, you can't help but become a double-faced hypocrite. Because they believe in the contradictions of religion, religious people themselves are falling into hypocrites with double personalities, and even Christianity is experiencing a crisis of being recognized as a bad religion.

Norman Gottwald, one of the great theologians, said that the Bible is a scripture that is difficult to understand without systematic study over a long period of time, and I will try to explain the truth of the Bible in the best honest way possible using the testimony and wisdom of grace I have experienced.

When I entered seminary nearly 30 years ago, 6 out of 10 new students at a neighboring seminary were lawyers. It is thought that lawyers who learned about the order of human society entered school to learn about

the ultimate order of God and the existence of God.

Many people who are interested in theology enter seminary, but achieving satisfactory results in the Bible and theology is not as easy as Norman Gottwald says. As a 69-year-old man who cannot be called young, I will do my best to explain the main points of the Bible and theology in an easy-to-understand manner for the sake of peace of mankind.

The Judeans in Israel, a very small nation, have the characteristics of a clan society, they have a strong hatred for other ethnic groups and have a strong customary law that prohibits dealing with other ethnic groups, because a small country can easily be destroyed unless it is firmly defended with nationalism.

Even if their Lord Jesus did missionary work to Gentiles, it is a separate matter for his disciples, who had lived within the framework of exclusive Judaism their entire lives, to missionary Christianity to Gentiles.

In Jewish customary law, there were extreme punishments such as treating Gentiles like dogs and pigs and even punishing them with stoning if they got along with them without discrimination.

The root of these evil laws is the religious blind faith and radical violence created by a group of priests. Because of the special nature of their profession, priests are obsessed with manipulating history and inciting emotions to drive people into the tombs of the self-deception and false religion their ancestors had created.

The Gospel of Mark, which was relatively close to the truth, was written first, followed by the Gospel of Matthew, which felt a sense of crisis due to the lack of the customary law of Jews' hatred of Gentiles, and the Gospel of Luke, written by Luke, a surgeon by profession, to a high-priest named Theophilus.

This paragraph is extremely insulting to the general public and remains an unpleasant mystery that will never be solved even for professional theologians. You may get the strange feeling that Mark is trying to force to convince the public by making up strange passages.

For Jews, it is also a paragraph that legislates the legitimacy of their racial prejudice.

Did Jesus really insult Gentiles like orthodox Jews? If asked, I will explain why this paragraph was added.

John Mark, the author of the Gospel of Mark, was an important Christian strategist who helped the apostles Paul and the first pope Peter, two great figures of Christianity, and created the first Bible, the Gospel of Mark.

John Mark, who also served as bishop of the large cities was in a position to answer the most critical question of Christianity : Why should Jewish disciples do missionary work to Gentiles?

I believe that this paragraph is a creation of Mark that he had no choice but to come up with in order to solve all the problems that Jewish Christians, including himself, had.

If you were in Mark's position, what kind of solution would you create to the problem Mark was concerned about between Jewish extremism of anti-gentile restrictions and Jesus' Christianity, which preached missions to Gentiles with no discrimination at all ?

This was a serious question of whether the early Christians in Israel could live or die at the hands of the Jews.

Mark first inserted this verse, which he came up with, into the Gospel of Mark, the first Bible, to represent the answer to the question of why, as Jewish apostles, they should do missionary work to Gentiles.

This paragraph is a significant paragraph that made up the thoughts of the Jewish apostles to persuade them.

By borrowing the authority of Jesus, Mark is persuading the message that Gentiles at least could be allowed and acknowledged to eat the crumbs left behind by the Jews.

It is very much a thoughtful justification of the gentile mission against the Jewish law of anti-gentile restrictions.

If Jesus really discriminated against Gentiles by calling them "dogs," apostle Paul's proud and clear missionary theology to Gentiles could never have emerged, and the logic that Jesus was the person closest to the qualification of God in human history cannot be established.

Humanity has been forced to unilaterally obey the authority of Christianity for two thousand years, and the result is great confusion and disorder in human society and the fall of Christianity.


My mission is to remove the contamination that has been put on Jesus, thereby providing the peace of the truth of God Jesus to all mankind, including Jews.

The Bible has existed as a time bomb that creates various prejudices, oppression, and violence at any time.

The Acts of the Apostles[a] is the fifth book of the New Testament; it tells of the founding of the Christian Church and the spread of its message to the Roman Empire.[3] Acts and the Gospel of Luke make up a two-part work, Luke-Acts, by the same anonymous author.[4]

Traditionally, the author is believed to be Luke the Evangelist, a doctor who travelled with Paul the Apostle. It is usually dated to around 80-90 AD.

After Jesus was executed, the reason why missionary work was possible without major interference was presumably because Jewish Christians kept the policies friendly to Judaism, even though Christianity was attacked sporadically by Jews.

Chapter 11 of Acts Acts chapter 11 describes the missionary work of the Jews, who were hostile to the ungodly Gentiles, as "the victory of Judaism over devouring the Gentiles."

Let's compare whether this was Peter's vision that actually happened or whether it was a fabrication of the author of Acts.

Luke showed considerable ability for fiction in his first epistle, the Gospel of Luke, written to the high priest Theophilus.

Among the four Gospels, Luke is the only one that makes Mary, the mother of Jesus, and Elizabeth, the mother of John the Baptist relatives and writes about the "revelation and completion" that the priests valued more than historical facts.

John the Baptist, who was beheaded while swearing at Herod, a Gentile king, was a patriot who was considered a hero by all the people of Israel. Luke matched John the Baptist and Jesus as brothers, and their mothers as relative sisters to relieve the wrath of the priests' group against Jesus.

Let me explain the reason why "Quelle" ("source" in German), which overlaps with the Gospel of Matthew and Luke, comes from. This overlap took place because when Luke wrote the Gospel of Luke, the contents copied from the exaggerated fat and long Gospel of Matthew naturally overlap with the Gospel of Luke.

When writing the Gospel of Luke to high priest Theophilus, Luke referred to the first Gospel of Mark and the second Gospel of Matthew, and also added his own special contents unique to the Gospel of Luke.

Because of the unique and special contents that appear only in the Gospel of Luke, the question of why Luke wrote the Gospel of Luke in particular could be solved.

Among the four Gospels, these verses are the ones created only by Luke's Gospel to tie Jesus and John the Baptist together in a brotherly relationship.

The fact that Luke added special parts that appear neither in Mark nor in Matthew, such as Jesus raising the dead, is also thought to be Luke's over-action to impress the high priest Theophilus. [Raising from the death](#)

Not only in the Old Testament but also in the New Testament, there are passages that stimulate the one-sided pride of Judaism, like minefields on a battlefield, so even if orthodox use violence based on the Christian Bible, it can be justified as an expression of religious belief.

Many theologians have speculated for centuries that a man named Theophilus was one of the high priests, as Luke stands out for his talent in emphasizing "revelation and completion," the parts that the priestly group puts more importance to. For this reason, it is more persuasive to believe that the fact that Peter's vision was written in Acts, Luke's second

epistle, was not factual, but rather that Luke created and included a part that priest Theophilus liked.

The reason Luke, as a disciple of Jesus, was able to write letters specifically to priests may have been because his profession as a surgeon made it relatively easy for him to approach the Jewish upper class.

Success or failure of spraying "son of God" paint job over poorly executed Jesus decides the fate of all Judean Christians, to be or not to be, which had to be desperately perfect and ultimately exclusive.



4 The manipulation exaggeration of rich tax collector "Matthew"

Matthew was hated by the Jews as a Roman official who collected taxes from the Jews for the Roman Empire, but the Jews could not carelessly attack him for believing in Jesus. Among Jesus' disciples, he was relatively wealthy and his social status was probably the most stable.

Given that the Gospel of Matthew quotes several passages from Jewish scriptures to portray Jesus as the Son of Jehovah, it is possible that Matthew, an elite Roman officer, was a law teacher "Pharisee" before becoming a tax collector in the Roman Empire.

A Pharisee is a teacher of the law who teaches the law in a relatively free status separate from the Sadducees, an orthodox priestly group that preached the law and taught Judaism in the temple.

"Pharisee" is an occupation that began when the Jews were exiled and is an occupation that teaches the traditions and laws of the people without a professional license.

Given the nomadic lifestyle and frequent movements, it is natural that indigenous jurists like law teachers are scattered throughout the Middle East, teaching their way of life, traditions, and religion, and blessing their livelihoods in the name of God.

22 And Peter took him aside and began to rebuke him, saying, "God forbid it, Lord! This must never happen to you." 23 But he turned and said to Peter, "Get behind me, Satan! You are a stumbling block to me; for you are setting your mind not on divine things but on human things."

Compared to Peter, a poor fisherman who made a living by catching fish, Matthew was an elite, no different from a nobleman. The status difference was similar to that of a master and a slave.

However, Peter was the disciple who became the first pope, and Matthew was a tax collector who collected taxes from the Jews for the Roman Empire, an enemy nation that was despised and hated by the Jews and the disciples, so he must have suffered from a considerable amount of resentment and an inferiority complex, I think.

Just as Trump, a criminal who grew up eating street food thrown to him by Jews and deserves to be locked up in prison, goes even crazier with the madness of a criminal, I think Matthew very effectively resolved his emotional grievances and inferiority complex by adding the part where he calls Peter "Satan" to his gospel.

The Bible is such an interesting fun book, and the seriousness of the problem is that mankind does not accept this manipulated fun as fun, but has used it as a tool to hate other people and invade and massacre neighboring countries.

Matthew's outstanding performance of cleverness has been the core of justifying the brutal racist nationalism of Israel, which has dominated humanity for 2,000 years as the basic metal frame of Christianity, by placing Matthew's masterpiece, the "Gospel of Matthew," at the very beginning of the Christian Bible.

5. The birth of wild Jewish nationalism.

The lavish pride of Judaism, a regional superstition of a tiny country in the near East, comes from the fact that it is fundamental to Christianity, grandeur mother religion of the Christianity.

All Gentiles, not just Jews, misunderstand Judaism as the origin, mother stem religion, of Christianity.

Jews can see all over the world their child religion, "the Christian churches," worshipping their nationalist god, Jehovah. Their pride is the reflecting and magnifying mirror of the Christianity and Jehovah, a racist religion and a racist God. The more Christianity exists and flourishes, the greater the pride of the Jewish people.

They could teach their children as a tradition, "Look at the Gentiles. They worship one cheap prophet of our Judaism. They call Jesus "the Lord" desperately out of many ancestor prophets of our Judaism, whose faith and obedience are more faithful and authoritative than poor Jesus." But this pride is utterly extinguished by the correct and plain fact that Jesus has nothing to do with Judaism.

I clarified this fact a decade ago, but it is true that timid theologians around the world are not disseminating it widely because they are frightened by possible attacks hardline conservative Christians and Jews.

Jesus began to be called "the Son of God" when evil spirits departed from him in the course of his healing, [Gospel of Mark, chapter 3](#) because of the custom of the ancients to call heroes and rulers "the sons of God." Jesus ordered sternly his disciples not to call Him the son of God, because the Israelites under Roman rule were guilty of treason by calling anyone "son of God" except for the Emperors, when "son of God" is a nickname of Roman Emperors. [Mark, chapter 8](#)

Nevertheless, this street nickname of Jesus, "son of God," grew bigger and bigger like a snowman and spread rapidly in Israel when Jesus passionately ignited missions and missions became prosperous. It also gave the Jewish priests a sense of urgency and alarm, which led them to accuse Jesus of being forced to denounce him to the Roman governor and put him to death for rebellion.

It was a common phenomenon around the world for ancient people to call heroes and kings "the sons of God."

Ancient people preferred a "son of god" as a ruler with powers second only to gods. The reason why the word "god" was used carelessly like in ancient Japan was because the cultural level of ancient Japan was underdeveloped.

This is because if you call the king a god, he is not free from the responsibility of having to explain even huge disasters such as wars, drought, disease, famine, and death.

[Gospel of Matthew, ch 8](#) Chapter 8 of the Gospel of Matthew shows how Matthew was eager to exaggerate Jesus as "the Son of God."

Matthew was a tax collector who worked for the Roman Empire, which Jews hated most.

After Jesus was executed, he had to work hard to make Jesus the son of Jehovah because their personal safety was guaranteed only by exaggerating and promoting Jesus as the "son of Jehovah," inheriting Jewish nationalism.

In order to justify "we are the same Jews in the same boat," Matthew and remained Jewish Christians had to modify the Gospel of Mark to create the Jewish Gospel in order to be guaranteed safe lives.

It is thought that Matthew, who was a wealthy tax collector among Jesus' disciples, hired a Pharisee (or Pharisees) who knew Jewish law very well to create the Gospel of Matthew, in order to play this game of survival.

Matthew, a clever opportunist, boldly made up a Jewish genealogy of Jesus and put in the beginning part of the Gospel of Matthew ([genealogy of Jesus](#)), and made Jesus a very faithful slave like "son of Jehovah and David."

It is Matthew's great contribution that the Gospel of Matthew is finally placed at the beginning of the New Testament and that Christianity is reduced to an imitation of Judaism, even though Matthew only put some Jewish hot peppers on the first Gospel, Gospel of Mark.

It is also Matthew's victory that turns Israel, a tiny nation in the Middle East, into a "nation that created God."

It is not surprising that the more exaggerated and manipulated a religion is, the more popular it becomes and the more successful it becomes.

This rule is also applied in the Bible, and the Gospel of Matthew, which has the most exaggeration and fiction, has surpassed the Gospel of Mark, which is comparatively the most true, and has become the first gospel.

The Gospel of Matthew, which is believed to have been written by Matthew the publican, is written in 28 chapters and is about twice as long as the Gospel of Mark, which is written in 16 chapters, with lengthy commentary.

Main articles: Divi filius, Imperial cult, Imperial cult (ancient Rome), Son of Heaven, and Sacred king throughout history, emperors and rulers ranging from the Western Zhou dynasty (c. 1000 BC) in China to Alexander the Great (c. 360 BC) to the Emperor of Japan (c. 600 AD) have assumed titles that reflect a filial relationship with deities.[1][12][13][14]

The title "Son of Heaven" i.e. 天子 (from 天 meaning sky/heaven/god and 子 meaning child) was first used in the Western Zhou dynasty (c. 1000 BC). It is mentioned in the Shijing book of songs, and reflected the Zhou belief that as Son of Heaven (and as its delegate) the Emperor of China was responsible for the well-being of the whole world by the Mandate of Heaven.[12][13] This title may also be translated as "son of God" given that the word Tiān in Chinese may either mean sky or god.[15] The Emperor of Japan was also called the Son of Heaven (天子 tenshi) starting in the early 7th century.[16] Among the Eurasian nomads, there was also a widespread use of "Son of God/Son of Heaven" for instance, in the third century BC, the ruler was called Chanyü[17] and similar titles were used as late as the 13th century by Genghis Khan.[18] Examples of kings being considered the son of god are found throughout the Ancient Near East. Egypt developed a long-lasting tradition. Egyptian pharaohs are known to have been referred to as the son of a particular god and their begetting in some cases is even given in sexually explicit detail. Egyptian pharaohs did not have full parity with their divine fathers but rather were subordinate.[19]:36 Nevertheless, in the first four dynasties, the pharaoh was considered to be the embodiment of a god.

Thus, Egypt was ruled by direct theocracy,[20] wherein "God himself is recognized as the head" of the state.[21] During the later Amarna Period, King Amenhotep IV/Akhenaten redefined the pharaoh's godship. He taught "there was only one god and only one person who now knew the god: Akhenaten himself" and assumed position of the ḥm ntr tpy (first servant

of god).[22]

He eventually eliminated all representation on his behalf by the priests of Amun as he also eliminated the god Amun, to solely lead worship identifying as the Son of the God he called Father, the latter which he recognized through the aten (sun), the vehicle through which the power of the God manifested to him.[23] Within a few years of his first epiphany and becoming king, King Akhenaten had dropped the priestly title of ḥm ntr tpy, but remained serving as the sole cleric and son of the Father in his rule of the Two Lands.[24] Later still, the closest Egypt came to the Jewish variant of theocracy was during the reign of Herihor. He took on the role of ruler not as a god but rather as a high-priest and king.[20]

According to the Bible, several kings of Damascus took the title son of Hadad. From the archaeological record a stela erected by Bar-Rakib for his father Panammuwa II contains similar language. The son of Panammuwa II a king of Sam'al referred to himself as a son of Rakib.[19]:26-27 Rakib-El is a god who appears in Phoenician and Aramaic inscriptions.[25] Panammuwa II died unexpectedly while in Damascus.[26] However, his son the king Bar-Rakib was not a native of Damascus but rather the ruler of Sam'al it is unknown if other rulers of Sam'al used similar language.

In Greek mythology, Heracles (son of Zeus) and many other figures were considered to be sons of gods through union with mortal women. From around 360 BC onwards Alexander the Great may have implied he was a demigod by using the title "Son of Ammon-Zeus".[27]

In 42 BC, Julius Caesar was formally deified as "the divine Julius" (divus Iulius) after his assassination. His adopted son, Octavian (better known as Augustus, a title given to him 15 years later, in 27 BC) thus became

known as *divi Iuli filius* (son of the divine Julius) or simply *divi filius* (son of the god).[28] As a daring and unprecedented move, Augustus used this title to advance his political position in the Second Triumvirate, finally overcoming all rivals for power within the Roman state.[28][29]

The word which was applied to Julius Caesar when he was deified was *divus*, not the distinct word *deus*. Thus, Augustus called himself *Divi filius*, not *Dei filius*.^[30] The line between been god and god-like was at times less than clear to the population at large, and Augustus seems to have been aware of the necessity of keeping the ambiguity.^[30]



6. "Go nowhere among the Gentiles and enter no town of the Samaritans."

All humans have the animal instinct to think easily, to judge easily, to achieve goals easily, and to easily obtain wild pleasure.

Human nature has an animalistic, individualistic instinct that virtually dislikes things like ethics, social justice, and social responsibility.

verse 7 : He called the twelve and began to send them out two by two, and gave them authority over the unclean spirits.

(Gospel of Matthew, chapter 10)

verse 5 : These twelve Jesus sent out with the following instructions :

'Go nowhere among the Gentiles, and enter no town of the Samaritans, 6 but go rather to the lost sheep of the house of Israel.'

Matthew, an opportunistic tax collector, boldly and cleverly added hatred for Gentiles, which was not present in the official version

of the first gospel, the Gospel of Mark, to his Gospel. Luke, a Gentile, copied from the Gospels of Mark and Matthew in his gospel,

which listed the priest Theophilus as the recipient, and in the process of creating his new Gospel of Luke, he avoided Matthew's

curses on Gentiles (skip copying Gentiles part of Matthew) because he was a Gentile himself.

While Peter, a poor fisherman and a disciple of Christ, and Paul, who received revelations directly from the executed Jesus, were eager to spread Jesus' universal message to Gentiles, including the Romans, Matthew, a member of the privileged group that remained in Israel, had to be eager to create a racist son, Jesus, who obeyed Jehovah as the Son of Jehovah, in order to maintain good relations with the Jews.

In order to contaminate Jesus' message with complexity and Judaism, the Gospel of Matthew was three times as long as the original Gospel of Mark, and the Gospel of Luke was four times as long, adding lengthy explanations of excuses.

Paul went to Jerusalem and stayed with Peter for 15 days. ([Gal 1:17-19](#))

It is assumed that Paul, who changed his name from the high Saul to the low Paul after believing in Christ, wrote down the teachings and deeds of Jesus for the first time.

This is because, since Paul had never met Jesus in the flesh while Jesus was alive, he must have heard many stories about Jesus' deeds and teachings from Peter, and **the whole amount of content would have been too much only to remember in his brain.**

Although the "Gospel of Paul," in which Paul recorded the deeds and teachings of Jesus, was not mentioned as "handed down," the theory of "Jesus Christ, the Son of God," that boldly appears from the beginning part in his first gospel, the Gospel of Mark, is more likely to have been created by Paul, a Pharisee law teacher who established the framework of "Christian son of God theology," rather than by Mark.

My theological hypothesis is that Mark would have asked and consulted Peter for additional advice after reading (or keeping) this seed gospel, the

"Gospel of Paul," and then created the first gospel, the "Gospel of Mark."




impious and rebellious religion by the absolute power of the Roman emperor, and thus faced persecution.



More tricks, exaggerations, lies of religion beat the truth in popularity.







I am not answered; I call aloud, but there is no justice. 8 He has walled up my way so that I cannot pass, and he has set darkness upon my paths. 9 He has stripped my glory from me and taken the crown from my head. 10 He breaks me down on every side, and I am gone, he has uprooted my hope like a tree. 11 He has kindled his wrath against me and counts me as his adversary. 12 His troops come on together; they have thrown up siegeworks against me and encamp around my tent. 13 "He has put my family far from me, and my acquaintances are wholly estranged from me. 14 My relatives and my close friends have failed me; 15 guests in my house have forgotten me; my serving girls count me as a stranger; I have become an alien in their eyes. 16 I call my servant, but he gives me no answer; I must myself plead with him. 17 My breath is repulsive to my wife; I am loathsome to my own family. 18 Even young children despise me; when I rise, they talk against me. 19 All my intimate friends abhor me, and those whom I loved have turned against me. 20 My bones cling to my skin and to my flesh, and I have escaped by the skin of my teeth. 21 Have pity on me, have pity on me, O you my friends, for the hand of God has touched me! 22 Why do you, like God, pursue me, never satisfied with my flesh? The **Book of Job** (/dʒɒb/; Biblical Hebrew: אִיּוֹב, romanized: *Īyyōḇ*), or simply **Job**, is a book found in the Ketuvim ("Writings") section of the Hebrew Bible and the first of the Poetic Books in the Old Testament of the Christian Bible.^[1] Scholars generally agree that it was written between the 7th and 3rd centuries BCE.^[2] It addresses the problem of evil, providing a theodicy through the experiences of the eponymous protagonist.^[3] Job is a wealthy and God-fearing man with a comfortable life and a large family. God asks Satan (הַשָּׂטָן, *haśśāṭān*, 'lit. 'the adversary') for his opinion of Job's piety. When Satan states that Job would turn away from God if he were rendered penniless, without his family, and materially uncomfortable, God allows him to do so. The rest of the book deals with Job successfully defending himself against his unsympathetic friends, whom God admonishes, and God's sovereignty over nature. < in wikipedia.org >



11. "Love your enemy" is not what Jesus taught but Matthew.

Norman Gottwald, the author of "The Tribes of Yahweh (Jehovah)," is a confident scholar who was quite certain about historical and literary background of where and what parts of the Hebrew Bible were created. Greek word "enemy" ἐχθρούς [echthrous] is someone you are hostile with emotionally not Gentiles like whom you should not get along with, the enemy of the Jews. This verse means to subdue your personal anger, which is guessed something like a well-minded local guru's teaching pharisee alike for the unity of the Jewish community.

If it had been written to love the "**gentile**" rather than a personal "enemy," the author Matthew would have been stoned to death, and the Gospel of Matthew could not have survived.


I think that the life we live is a test paper that records our trials and



Ernest Wright strikes several characteristic notes in the preface to his 1952 essay *God Who Acts: Biblical Theology as Recital*. He says at one point, "The writer can make no claim for originality in the discovery" of the importance of the theology of recital for biblical thought; at another, he thanks two readers of his manuscript who "made a number of valuable suggestions (which) kept me from overstating my thesis." These two comments together, the first reflecting his humility, the second the zeal with which he sought the clarity of steady and unitary vision, hint at Wright's chief concern, teaching. The first reference was surely intended in the plainest sense, as a simple admission of reliance on the work of his fellow students of Oriental traditions, and yet in retrospect it is hard not to associate the comment with similar prophetic disavowals of originality. The poet of Deut 32, the prophetic "lawsuit" Wright treated in one of his most influential papers, would similarly have refused to claim originality; when he says, "May my teachings drop like rain," he means, after all, only the teachings he is passing on, and the Hebrew word he uses, *light*, seems to refer to what is received.

Wright's self-consciousness of the danger of overstatement does not bespeak uneasiness with his own work, so much as an awareness of the need to have theological reflection aspire to the dynamism of the prophetic presence in Israel. Over the past quarter-century, it has become clear that Wright's thesis in that book was overstated, but it has only become clear because the dead hand of propositional and systematic dogmatics has been loosened from the neck of biblical studies, in large part resulting from Wright's efforts. He felt that too often biblical scholars made claims that were meaningless in a biblical framework, so he formulated counterclaims to deal with the facts in a better way. Some of his hypotheses no longer carry the impact they did in 1952; but if we can see that now, it is only because he made regard for certain modalities of biblical recital seem as crucial as they must be.

If there is something of a scientific ring to this description of Wright's theology, that is fitting, for he was a scientist as well as a theologian. He behaved as one not only in according primacy to the raw data of archaeology—and a lifetime of attention to antique cooking ware certainly deserves recognition in itself—but also in a movement away from the fragile self-reliance of many scholars. He was equally frank in confessing his need for consultation of text-critics in biblical studies as for that of underwater specialists (geological and ecological) in archaeology. The unavoidable comparison with Albright, his teacher, must be made, if only to show that it is not at all invidious. As archaeologists, their relationship is one of co-workers in a single, continuous tradition; three decades separated the Tell Beit Mirsim excavations from those at Shechem. As students of biblical texts, Albright and Wright addressed different realms of humanistic thought. The theological claims of *God Who Acts* would have had no place in *From Stone Age to Christianity*, with its general framework of intellectual history. Wright's work speaks to a much more insistent set of concerns, concerns that surround us every day; it goes without saying that those concerns had a fresh brutality in 1952, in the years immediately after Hiroshima and Dresden, and reasonably enough, there was no need of restating or referring to these ubiquitous concerns in the essay. Albright's expansiveness addresses us in the context of all of history and helps us lose our misconceived bearings much more than it helps us find new ones. The contrast can be put plainly by observing that Albright took over a plodding *Bulletin* and made it his own, while Wright founded the *Biblical Archaeologist* and made it the vehicle for two generations of scholars. Albright sought to bring biblical revelation to modern man by filling in the long view of history; Wright performed that task more simply by juxtaposing biblical and modern humankind in the company of the God who acts for them both.

BIBLICAL ARCHAEOLOGY

Our second "giant" was the first empire builder of history. He was a Semite named Sargon (cf. Fig. 13), the founder of the Dynasty of Akkad (*ca.* 2360-2180 B.C.), and Mesopotamia's greatest king during the 3rd millennium. The Sumerians and the Semites had lived side by side in Babylonia for a long time, and during the Dynasty of Akkad the Semites had come to dominate the country. Sargon extended his rule over the whole of Mesopotamia and, for a time at least, over Syria. He is even credited with expeditions as far away as southern Arabia and Asia Minor. So famous were his exploits that he became the Charlemagne of his day. An epic was written about him, entitled "The King of Battle". This epic was circulated for centuries and was read and copied as far away as Assyria, Asia Minor, and Egypt. Curiously enough, a story told about him at a much later time is strikingly similar to that of the childhood of Moses. We are informed that he had a lowly birth, that his mother bore him in secret, placed him in a reed basket, and set him adrift on the Euphrates. He was rescued by a gardener, adopted, and grew up to become king. The dynasty founded by Sargon brought about a revolution in artistic standards, and the quality of workmanship was scarcely surpassed even by the Egyptians during the two succeeding millennia.

News of the success of King Sargon's Mother's basket plan sparked what would later know as the great baby rush.

12. How can you live with "Do not judge?"

Among my acquaintances, there was a person who received a score that would allow him to enter the Law School, but he went to business school because his mother said that the Bible says, "Do not judge" and that he could not enter a department where some conservative Christians would condemn him.

The Bible justifies the absurd and groundless stubbornness of the local law teachers by comparing them to God or Jesus, and the history of mankind has been oppressed for a long time with stubbornness and violence. Now, mankind must become mature and free itself from such stubbornness and violence.

If then the occupation of the author of the Gospel of Matthew was a Pharisee, different from the Sadducees who governed the religious laws of Israel in the temple, how can the passages in the Gospel of Matthew criticizing the Pharisees be explained?

I was a student at a Jewish studies school 30 years ago, taking a class taught by David Winston, a renowned rabbi scholar, and one of the most shocking passages I ever heard was, "A Pharisee criticizes another Pharisee."

Those who wrote the Bible manipulated the Bible to convince those who could harm them and repeatedly committed "religious deception" by deceiving themselves.





blind eye to crimes of lies and violence, then they are no longer intellectuals.



Tell el-Amarna in Egypt. The original discovery was made by an Egyptian peasant woman in 1887; and since that time many more have been found, including a few from the ruins of Palestinian cities. The letters were written, for the most part, by Asiatic kings and officials to the Egyptian court. Those from Canaan reveal such a chaotic state of plot, counterplot, and contradictory accusation that it is virtually impossible to tell truth from falsehood. A number of the letters complain about trouble from a people called *Hapiru* (pronounced in Canaan '*Apiru*'), a word connected in some way with "Hebrew" (see Chap. III). Many scholars in the past have interpreted these letters to mean that a great invasion from the desert was taking place, an invasion to be connected in some way with the Hebrew conquest of Palestine.³ Recent students of the letters, however, claim that there

is within them no evidence whatever of such an invasion. The '*Apiru* are considered in the letters as "bandits" or lawless gangs, a number of them, at least, ill-paid mercenaries who were joined by an increasing number of people from the oppressed population. In addition, the term is applied by local kings to neighboring kings and their armies who are seizing land and towns. The king of Byblos, for example, assumes that anyone who takes his land is an enemy of Pharaoh and calls those who do so '*Apiru*. Yet those thus named write to Pharaoh, protesting their loyalty. In this case, the name is used as a base accusation, like the modern tendency to call someone disliked a communist. It is impossible, therefore, to see any evidence of a great invasion or to connect the disturbances with the Israelite entry into Palestine, because the '*Apiru* were already within the land and were not new invaders. The letters nowhere contain reference to an invasion; the attackers labelled '*Apiru* were people of other city-states.⁴

The studies of W. F. Albright on the political geography of the Amarna period have shown that

Early Israel: A New Horizon

Since each indication by itself is uncertain, together they are inconclusive. Nevertheless they are suggestive, and poetic indications of an "origin" of Yahweh in Edom (Deut. 33:2; Judg. 5:4; Hab. 3:3) do not necessarily contradict the suggestion for the thirteenth century. The location of Israel in the north of Palestine fits the most likely reason Merneptah's scribe mentioned them at all: the tribal elite of Israel and their paramilitary forces functioned as an extension of Egyptian military control in the buffer zone along Egypt's border with the Hittite sphere of influence, just as did Abdi-Ashirta and Aziru of Amurru. Egypt's overriding interest in Asia had all along been in Asia's role as buffer territory: the best defense is a strong offense. In the thirteenth century, the presence of Egyptian officers north of Bethshan clearly diminished. As *shasu*, Israel constituted a threat along the route to the north. What better way to control the threat than to digest it into the imperial order? Service in border and buffer zones has been the commonest reason in the history of Palestine for the administrative support of tribal strongmen and their hosts, and for state promotion of tribal alliances, all typically erratic in their loyalty. A few of the numerous examples that could be cited include the relations tribalists had with Assyrians in the Negeb and Sinai in the seventh century and with Greeks in the fifth and fourth centuries, and between Romans and tribalists on the Syrian border during the empire; the support of the Ghassanid kingdom by Justinian and the Lakhmid alliance by the Persians; and the many cases detailed by Sharon and Abu-Husayn for early modern Palestine.

The Merneptah stanza claims that Israel has been annihilated. Obviously Israel was not annihilated. In terms of political reality, unless the text is sheer fantasy it could only mean that Merneptah brought Israel under his control, as he did the towns named in the stanza. Israel's

leaders were either neutralized, as Egyptian protégés, agents, or clients, or replaced. It would be interesting to speculate about the relationship of the Israelite tribal elite to Hazor, at this time defunct. The tribal elite may also have turned over taxes as tax farmers of villages, including tribal villages, they controlled. Like other local rulers, they may have had to supply *corvée* from villagers for the farming of Egyptian crown lands in the vicinity of Bethshan or Hazor. Given the nature of tribal politics, this was not a contradiction of the tribal structure's opposition to the state. Again, the tribe as a whole undergirded the power of the tribal elite at the interface of tribe and state. Israel as a force was not only a creation of both its tribalists and Egyptian New Kingdom policy—it was an arm of Egyptian power.

Another hint that Israel's elite chiefs and priests were related to Egyptian imperial control is that in the tenth century the prime chief of Israel and others associated with him in the time of a certain Ramesses were remembered as having Egyptian names. (There was an unbroken succession of Egyptian kings named Ramesses during the entire early Israelite period.) These chiefs and priests included Moses, later associated with the cult of Dan in the vicinity of Hazor, Aaron, Phineas, Hophni, Merari, and possibly others. (Phineas's name, meaning "swarthy" or "black," indicates he may have been a black African; other leaders of early Israel with Egyptian names may have been black too.) Although these names are few, they belong to apparently important individuals. Moses' traditional place of burial in the hills northeast of the Dead Sea suggests that he may have been a chief of Israel after the beginning of the emergence of highland villages in the twelfth century.

Why did these chiefs and priests of tribal Israel have Egyptian names? The power of the single strongman in

tribal society was a function partly of consensus politics among the strongest elements in the tribal block, but also of a power struggle within the block and of patronage from the state. The form of state patronage in New Kingdom Palestine is clear: Egypt removed hundreds of Palestinian elite sons and daughters to Egypt to be raised there as hostages and socialized as loyal Egyptian servants and clients. A standard motif of Egyptian reliefs of sieges of Palestinian cities shows the besieged princes offering their children from the city walls to the conqueror as hostages. A tomb painting of the vizier of Tuthmose III shows Palestinian princes presenting their tribute in Egypt, including "the children of the princes of the southern [that is, Palestinian] districts . . . who were brought as the best booty of his majesty . . . to fill the workshop and to be serfs of the divine offerings" of his god.⁸ Amenhotep II in one campaign brought back to Memphis some 2,000 Asians, among whom were 232 rulers' sons and 323 rulers' daughters. In other words, one-fourth of his captives were elite hostages. These were brought up in Egypt and then frequently returned to Palestine as rulers loyal to Egypt. In an Amarna letter from the Palestinian prince of Gaza and Joppa, the prince avers, "When I was young, pharaoh brought me to Egypt, where I served the king my lord; I solemnly stood in the city gate of the king my lord." Following a second campaign, Amenhotep II brought back in addition to princes themselves 3,600 *apiru*, 15,200 *shasu*, and 36,300 *Hurru*, with all their goods, sheep, goats, and cattle. Many Palestinian proxies for Egyptian administration were brought up in Egypt, though they often kept their Palestinian names. That Moses kept his Egyptian name indicates his Egyptian derivation and pro-Egyptian position, though he may have been Palestinian in origin.⁹ He might have been one of the Medjay tribesmen sent in to police the Egyptian realm,

or the son of such a tribesman born in Palestine. Or he might have had an Egyptian name simply because he was an Egyptian, an ambitious, adventuresome prince or tribal renegade of the Nile.

Israel's relationship to Egypt was as complex and changeable as tribal relations always were. Moses played a double role of loyal ally and rebel to pharaoh. Border forces were susceptible to defection on their own side and bribery from the other. Hittite fighters are attested in Palestine right into the period of the Israelite monarchy. Both mercenaries and employers were perennially unreliable. It was said that Aqili Agha, a bedouin strongman from Egypt set up in northern Palestine under Egyptian occupation there in the nineteenth century C.E., was "a marauder when in rebellion and a man who lived off the villages by protection at other times."¹⁰

Given the decrease in overall resources in Palestine during the later New Kingdom, an increase in factionalism is likely and expected. It is safe to assume factionalism grew, though there is no direct evidence for it. All we have, thanks to Merneptah's propagandist, is a reference to a single tribal Israel, since, for both Egypt and the most powerful of the tribal heads of northern Palestine, it was more useful to publicize the mask of unity and political agreement than the reality of inciting one strongman against another in the attempt to neutralize them both. If the head of this unity at some time between Merneptah and Ramesses VI is known to us, his name was Moses.

At least some of the Israelite tribal elite were *abiru* in the sense that they were aliens in Egypt or, as Palestinian elite with long-term residence in Egypt, aliens in Palestine. As proxies for Egypt in Palestine, the tribal elite were displaced mercenaries. Moreover, many of the tribal members were displaced persons, uprooted from town,

village, or homestead as a result of the decline in settlement and production and their need to make a living elsewhere in the border turmoil between the great powers. On these grounds, apparently, the term *ibri*, or "Hebrew," was adopted into Israelite tribal culture, if *ibri* comes from *abiru*, as most historians continue to believe possible. The typical Israelite tribal leader was a client *abiru*-ite, or "alienite," an identity that traced back to tribal Israel's significant displaced population and official Israel's proxy role, roots that were forgotten within only a few generations. The terms *shasu* and *abiru* were not mutually exclusive. In the thirteenth century B.C.E., chiefs of Israel could have been both. And of course the designation Israel was far from inclusive. Thousands of non-Israelites in Syria and Palestine were *shasu* or *abiru* or both.


The compact between Egypt and Israel lasted in one form or another until David. With the collapse of the New Kingdom about 1150, Philistine lords took the places of their Egyptian counterparts and renewed their long-standing threat to Egypt. In the struggle between the Philistines and Israelites, Egypt presumably took Israel's part more than the Philistines' part, to the degree it was able, for the same reason it supported rebel movements against the house of David in the tenth century. Some early Israelite rhetoric preserved in the Bible may be hostile toward Egypt, such as the song of Miriam in Exodus 15; but most is not. The intensity of hostility toward Egypt expressed in J, the history of Israel written in the court of David, is a measure of how strongly this upstart Philistine-backed monarch had to weigh in against the custom of amity or collusion between Egypt and the chiefs of early Israel, whatever the thrust of early Israelite ideology. The southern Judahite pastoral tribal story of flight

from Egyptian *corvée*, the exodus, was the tradition adopted by David for flattering his Negeb tribal allies and highlighting his anti-Egyptian stance. As explained further in chapter 7, it had nothing to do with the origin of Israel.




